The purpose of this study was to find out the application of Grammarly to improve the efficiency of writing skills in senior high schools. Researchers used descriptive qualitative methods by using interviews, observations, and questionnaires. In this study, 30 participants were observed, and at the end of the interview, 8 students with high questionnaire results were taken to be interpreted. Participants are high school students studying in the 2022/2023 school year. The results and discussion show that Grammarly helps high school students learn writing. Students are interested and confident in using Grammarly with the various advantages available during the learning process. This tool is also practical to use and easy to access, so it doesn't make it difficult for students. Students showed positive views of using Grammarly and felt that it was more helpful in exploring writing skills using Grammarly with their various advantages.

This matter relates to the main points listed in the main idea. The fourth is an expression, choice of words, and point of view. It focuses on the tone of the writing and shows the author's attitude toward the topic of discussion. This attitude will determine the choice of vocabulary and how the writer shares ideas. The last is spelling, grammar, language, and punctuation. Good writing requires these three things to create effective communication between writers and readers to express ideas clearly and accurately. So, writing difficulties can be solved by utilizing technology in learning.

Teachers must pay attention to the conditions of students towards technology-based learning to develop the skills possessed by students. So, what the teacher has to do is look for online-based technology that is suitable for developing students' writing skills. This technology is a tool for solving student problems. In addition, another feature is checking for grammatical errors by presenting the correct use of grammatical rules. Grammarly can offer the right choice of words (word choice) and the use of vocabulary according to the context in the discussion of the sentence. Applying automatic feedback will give teachers high-level writing skills, further developing students' writing enthusiasm and quality.

B. Literature Review

The primary purpose of learning English using Grammarly learning technology is to help students improve their knowledge skills related to writing abilities. According to Ghufron & Rosyida (2018), Grammarly is one of the best grammar checkers in the market. It proves invaluable for students who want to improve their writing and English vocabulary, and the Plagiarism checker can also help avoid the adverse effects of writing only from other sources. The application in the classroom of Grammarly allows for correcting the wrong elements of writing. This becomes natural when Grammarly becomes a learning technology widely used by teachers, especially students learning English. Ambarwati

As it is known that the connection to access this technology must be stable so that this technology can run efficiently. In addition, the more you write, the fewer adequate words. Of course, there will be many mistakes that must be corrected. In terms of work effectiveness, Grammarly is less effective because it takes a lot of time. Fitria (2022) One of my biggest complaints with Grammarly is that some of its suggestions are just plain wrong. While they do an admirable job of detecting most errors and making suggestions accordingly, they sometimes fall short in writing context.

C. Research Methodology

In this study, researchers used descriptive qualitative research to describe the study's results. Descriptive qualitative research is based on facts that form information data. This type of research aims to explain in detail related to phenomena and develop theories and social complexities that exist in education related to the application of Grammarly technology in learning English. Application of Grammarly tools to improve writing skills. Work best in our class to seek classroom solutions and improve student learning. Fahmi & Cahyono (2021) argue that classroom action research is carried out in several steps. First, researchers make observations related to teaching to overcome problems in learning and provide questionnaires. The next step is to withdraw the questionnaire and follow by observing the teaching and learning activities. The third is to reflect on how the strategy improves or influences students' writing skills and analysis. Finally, provide conclusions and results of the discussion. This research was conducted at a tenth-grade senior high school in Malang.

The researcher chose this school because the school applies grammatical learning technology in learning English. In addition, the school is also a bilingual school, making it easier to conduct this research. Moreover, this research can also find out this school's condition and the problems students face in writing English. Class X MIPA 1, the research subject, is one of the bilingual-based classes. This class has 30 (thirty) students consisting of 10 boys and 20 girls in the 2022/2023 academic year.

According to Mubarok et al. (2020), Research Instruments are tools that researchers select and use in collecting activities so that these activities become systematic. The instruments used in this study include observations, questionnaires, and interviews. From a total of 30 students, eight samples of students will be taken related to the use of Grammarly in learning. D. Results and Discussion

Third, Grammarly premium presents more complete Features still. The advantage of Grammarly Premium, this service has a proofreader or Editor, which is more costeffective than hiring someone. Like a personal assistant, this service is ready to accompany its users, prepared to help whenever needed as long as they are connected to the internet. Grammarly helps users more easily find mistakes that can sometimes still slip through after double-checking. Likewise, the Grammarly Business program features differ significantly from the Premium version. This service offers an alternative to optimize the quality of the user's text.

Fourth, more than just spell-checking tools currently, many spell-checking tools are installed in browsers and document applications such as Microsoft Word. They offer advanced features according to users' needs, but Grammarly supports almost perfect features. Technically, Grammarly helps you focus on improving what you write. One of them is the tone detector feature. In addition, this web service performs its corrections in four different zones. The four zones highlight correctness, clarity, engagement, and delivery. Corrections of all these zones appear in different color codes for better management.

Finally, Plagiarism Check For some people, the plagiarism feature may not be necessary. But different from the needs of academics and students. The plagiarism checker helps authenticate writing and provide a solid identity for the author. In a business context, especially for website content production, search engines hate duplicate content, and this action also triggers a litigation lawsuit. All of these fears can be overcome by testing your writing on the plagiarism checker feature in Grammarly.

b. The weaknesses of Grammarly in learning

If you already know some of the advantages, the next thing you need to know is that there are some drawbacks to the Grammarly application. Correction continues to weaken as the number of observations increases. Second, the Clarity Feature is Less Optimal. In this feature, only the passive form is corrected, and there is no suggestion to change it to active. Whereas for research purposes, more use of passive sentences to change the sentence's focus. Third, the plagiarism feature is not extensive. The plagiarism feature only checks plagiarism from the writing database on website pages. This has not yet been proven whether plagiarism is for journal publication. The part detected as plagiarism is usually only the general writing part.

So, from the above description, both in terms of advantages and disadvantages, it can be concluded that the Grammarly application must be adapted to the user's abilities because if you prioritize Grammarly without any self-correction, it will cause errors in



The view of Grammarly software







Furthermore, the clarity function in the lower right corner serves as a suggestion for sentence clarity which is usually given a blue underline color in sentences that are not appropriate and the effectiveness of a sentence that is too monotonous. Finally, the function of engagement is to make sentences use more effective words and avoid repeating words in sentences. A blue line usually indicates it in sentences that need to be corrected. Of all the menu functions, there are limitations between the premium and free versions of Grammarly. So that all can be accessed when they have Grammarly premium.

4. How to use grammar software

Writing English text according to the rules for writing English is an absolute must be obeyed. Some micro errors such as verb agreements, phrases, wordiness, or the use of words that are not effective and efficient must be avoided by a writer, such as integrating an automatic grammar correction tool, namely Grammarly. 



Spelling and grammar check feature



c. Explanations and word suggestions







Grammar rules explanation feature



After the questionnaire administration, the researcher found some results which later explained by stating the parts of each statement in the questionnaire. Then, the results are presented as follows.

The first statement of 5 participants mentioned that they had known the use of grammar since entering senior high school. The presentation of 8 samples showed that 4 participants already knew the software, and the resulting yield, if specified, becomes 100%. This

statement is very significant because it relates to when grammar started to help their learning activities when learning English in high school. Furthermore, in the second question, the statement in the questionnaire format found that 60% of participants would use grammar on an ongoing basis after they had completed the study period, and only 40% stated that only during the study would they do this. However, those who use grammar are still guided by a tutor. It is in line with Ghufron & Rosyida's (2018) statement that the supervisor must continue to oversee improving the manuscripts that students write even though they have used Grammarly.

Furthermore, based on the choice of statements in the questionnaire questions, the authors know that the high frequency of appearances related to how to use grammar is during the writing process in Microsoft office as much as 20%; Meanwhile, students who directly access the web are as much as 40% and with an upgrade system as much as 20%; and finally with mobile phones based on Android/IOS as much as 20%. Based on the frequency counts of time shared by the participants, the authors know that the regular neatness of using grammar per week is 60%, while in the daily use format, it is up to 40%. All are known when they write their English writing assignments. The results of this choice are in line with what was stated by Mubarok et al. (2020) that Grammarly can be accessed online through several browsers or search engines, and notable features such as Chrome, Safari, and firefox and support its operation on Mac, Windows, Android, and iOS device.

In terms of when the participants used Grammarly, 100% of the participants chose to write English writing assignments. Meanwhile, participants used grammar to learn vocabulary, as much as 80%. In addition, the participants used Grammarly for artificial intelligence-based writing assistance, as much as 60%. This shows that the dominance of grammar occurs when the participants write English text (English text). Researchers can understand this because Grammarly can detect errors in writing scientific papers automatically, as stated (Daroina et al., 2022). it is in line with the research of Ashrafganjoe et al. (2022) state that the Grammarly thesis is helpful in their writing. Grammarly is considered easy to use, has good suggestions and explanations for grammatical errors, has good grammatical accuracy, and has faster corrections.

Besides that, regarding self-confidence when using Grammarly, participants prefer points to be more confident with a frequency range of 85% and participants slightly less secure by 5%. Finally, participants who chose the 'not confident' option reached 10%. This is because, for the free version of the Grammarly feature, access limitations make their authorship inaccurate. Confidence is the most significant proportion point because it is recognized by Koltovskaia (2022) that Grammarly is a good learning tool and can make the learning process more effective when applied to language learning.

Furthermore, 80% of participants prefer to use support or recommendations from Grammarly conditionally or do not follow the advice from Grammarly. This may be influenced by the needs and the type of English text needed, so it is not possible to use it as a whole based on the recommendations given by the grammar itself. 20% of participants used overall recommendations on Grammarly without checking word compatibility. This percentage shows that some students prefer to use whole words. The researcher found that grammar helped their English task related to grammar correction. Grammarly helps them

identify errors and correct errors in their texts and directs them to become independent learners (Javier, 2022).

In short, it can be concluded that in the discussion regarding the use of Grammarly, 8 participants gave a positive view of their assistance when writing English writing and this research has provided a description that Grammarly offers assistance to high school students in learning English through automatic feedback with learning technology latest. This is in line with what Daroina et al. (2022) stated effective learning technology is when it can be applied in education and the object being taught can feel comfortable. In addition, introducing grammar in high school can help participants reduce writing problems in English, such as assignments and others. This statement is in line with research from (Koltovskaia, 2022).

E. Conclusion and Suggestion

Using Grammarly greatly facilitates senior high school students in developing their writing skills. Students will be more confident when using Grammarly in their writing. So, in conclusion, the researcher found that 80% of high school students prefer to use the recommendations and support from Grammarly or not to follow Grammarly's suggestions. 20% of participants used overall recommendations in Grammarly without checking word compatibility. This percentage indicates that some students prefer to use whole words. The researcher found that the grammar helped them in their English grammar correction task. Grammarly helps them find mistakes and correct errors in their texts, making them independent learners. In summary, when discussing the use of Grammarly, 8 participants commented positively on its support in writing English. This study provides an overview of how Grammarly helps high school students learn English automatically.
